

**About Internship**

This Social Internship is a unique volunteering opportunity for enthusiastic young minds to explore the grassroots realities and the most relevant social issues in society for creating sustainable solutions to achieve Global Goals. This Internship Program is specially designed to involve Intermediate Class Students for practical learnings to enhance their creativity and understanding about social development. It is a **certificate-based program** that enables young minds to upgrade their profile with field-based knowledge, administrative skills, management & planning through action research projects concerning UN Sustainable Goals.

It aims to enhance in-depth knowledge, Inner Development, and leadership qualities of youth by involving them in charity and philanthropic work to experience humanity and pleasure for doing something good. It also envisions creating a community of young social reformers to bring a reformative change in the society by making a **Chain of Changemakers**.

The Internship certificate provided by the organization will help the interns to get recognition at international level due to the organization's accreditation with the United Nations and international presence. It will also enable access to networking and innovation exchange.

**Eligibility Criteria**

Students who have appeared in the board exam of class 10<sup>th</sup> in the academic year 2022-23 and equipped with basic internet, computer training and having valid email address for virtual trainings will be eligible for this internship after the completion of their Exams.

**Location of Internship**

Internship training and its related activities will be performed in his/her School only (online /offline both)

**School Intern Coordinator/Nodal In-charge**

An Exclusive Coordinator from Each school will be designated to coordinate and monitor the internship activities and its Impact.

**Number of Interns from Each School**

05 Students per school.

**Roles and responsibility of Intern:**

1. Inter will participate in all online / offline training and orientation sessions organized by the organization.
2. Interns will ensure their active participation in all school activities related to malnutrition eradication programs.
3. Students will ensure their active participation in data management and report management training.
4. Interns will provide their support for conducting the in-school activities like workshops, competitions etc.
5. Identifying the real- time challenges for better implementation of ongoing interventions.
6. Intern will be responsible for timely data reporting.

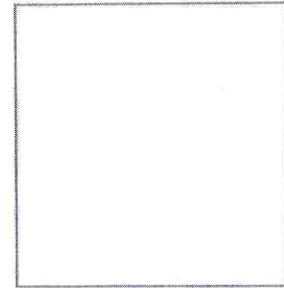
